

### ALUMNI CHAPEL CAMPAIGN PROGRESSES

Construction of the new Cedarville College chapel is progressing rapidly. The floor was poured September 30 and the steel roof girders were up two weeks later. The brick walls are almost finished on two sides of the building and the roof will be on before any bad winter weather arrives.

Many Alumni have rejoiced at the building of the new chapel. They remember a time when they were crowded into Alford Auditorium, or when they tried to concentrate while watching the chapel service on closed circuit TV—and are grateful for the Lord's new provision. The time is fast approaching when the current students at Cedarville College will be able to enjoy the worshipful atmosphere of a new chapel.



The Alumni attitude of understanding and concern for the need of a new chapel facility is reflected in their financial support. Already Alumni have supplied \$25,000 for the project.

Cedarville College needs \$500,000 by May 1976 to remain on schedule for chapel construction. The Alumni

# SOUNDING Alumni Awards Presented



At the Homecoming Luncheon, Saturday, October 18, Dr. George Lawlor and William M. Pierson were honored as this year's Alumni award recipients. Dr. Lawlor was presented the "Honorary Alumnus" award and Bill Pierson was recognized as "Alumnus of the Year".

The teaching of Dr. George Lawlor, Honorary Alumnus, has had a profound influence upon the lives of hundreds of young people who have had the privilege of sitting under his instruction during his past 16 years at Cedarville College.

His courses in Greek grammer and exegesis, as well as the variety of Bible courses he has taught, have provided a firm foundation for the ministries of many. But Dr. George Lawlor has imparted more than academic knowledge to his students. Through his teaching, Dr. Lawlor has provided a pattern of sincerity and spiritual maturity for students to follow in becoming a servant of Christ.

15 years of pastoral and 7 years of teaching experience. He is currently teaching only a partial load in preparation for full retirement. He has given almost 25 years of service for Christ through teaching.

Dr. Lawlor holds several degrees: B.A. Barton College; B.D., Th.M., and Th.D. Grace Theological Seminary. Because of his devotion to Cedarville College and its students, the Alumni Association wanted Dr. Lawlor to be able to call Cedarville "Alma Mater".

Alumnus of the Year, William Pierson, is a 1965 graduate of Cedarville College. He attended Grace Theological Seminary, receiving his Master of Theology degree in 1968.

Upon graduation from Grace, Bill joined the Association of Baptists for World Evangelism (ABWE) as Assistant to the Treasurer. In 1972 he accepted the position of Treasurer. This job carries with it a major portion of the responsibility for the operation of ABWE.

Bill has also distinguished himself as a significant speaker in the field of missions. He has represented ABWE at many conferences and candidate schools and spoken for mission boards other than his own. During the winter of 1974 he was the keynote speaker for the South American field council assembly.

William Pierson is an Alumnus who has clearly decided to use his talents in significant service for the Lord. Bill said that he is truly humbled by the award-and looks upon it as a challenge to himself to be even more committed to serving Christ in his life.

Cedarville Alumni Chapters have now been organized in four major areas: Dayton, Cleveland, and Akron, Ohio; and Philadelphia, Pennsylvania. These geographical centers alone account for over 30% of the College's graduates and former students.

Plans for the future include the organization of chapters in four additional cities and the creation of a program for locations that have only sparse Alumni representation.



# American Revoluution?

As the United States approaches July 4, 1976, a sudden wave of interest in American history has enveloped the nation. People at every level have suddenly become sensitized to the birth of their nation.

And yet some are perplexed by a nagging question. Can a Christian legitimately celebrate a "Revolution" in light of Romans 13? Webster defines revolution as "a sudden, radical, or complete change; a fundamental change in political organization, especially the overthrow or renunciation of one government or ruler and the substitution of another by the governed."

Is this what happened in America two centuries ago? The most obvious answer is yes, but the most correct answer is a resounding NO. In fact, given the above definition, there never was an American Revolution!

Very few references to a revolution are to be found in the writings of the founding fathers. The term is actually the designation of historians. More specifically, it best fits the Economic Determinist School of historiography. Men like Merrill Jensen, Charles Beard, and Carl Becker considered the struggle of 1776 to be an internal revolution of the poor masses (radicals) against the rich (conservatives). This interpretation simply does not fit the evidence. America had some rich and some poor, but most people rested between these extremes.

When the first settlers came to America, they brought with them charters that had been granted by the King of England. These charters guaranteed the colonists of all their RIGHTS AS ENGLISHMEN in spite of their emigration. Further, they were assured that these basic rights would be passed on to future generations in America.

At the time the King granted these charters he was in fact a ruling mon-

arch. However, during the course of the seventeenth century, the English people developed an increasing concern for representative government. This concern led to the so-called "Glorious Revolution" of 1688-89 in which royal power was greatly expanded. As a consequence the representative wing of the English government became much more powerful. During the same century the American colonists were developing their own representative government as exemplified by the House of Deputies in Massachusetts and the House of Burgesses in Virginia. The question eventually would become which representative group had control in America; Parliament or the Colonial legislatures?

This question clearly surfaced at the time of the Stamp Act (1765) and rested at the heart of such subsequent issues as the Declaratory Act, the Townshend Duties (including the Tea Tax), and the Intolerable Acts. The documents of this period from 1765-75 are filled with this theme as the colonists repeatedly speak of their rights as Englishmen. Even when taking up arms against the mother country, the First Continental Congress pleaded that these ancient rights be respected and the Empire relieved of the "Calamities of Civil War" (July 6, 1775). Only after a year of conflict was the Congress reconvened. The Second Continental Congress then hesitantly moved toward independence.

In this whole process the American position remained remarkably consistent. The colonists were defending the rights guaranteed to them at the time of their emigration by their original charters. What occurred was not a revolution! It was a War for Independence in which the colonists sought to preserve—not overthrow—the status quo. This is the context in which the Christian may best formulate his viewpoint on this fascinating period of American history.

This means they will be able to establish independent Baptist churches in the Department of Guiglo in Ivory Coast. They left August 18 for the field.
