Collins Memorial Fund Reaches Goal

The eight sons and daughters of Andrew and Mary Rife Collins have reached their goal of contributing \$50,000 for the remodeling of the "Old Science Building" as a memorial to their parents. The building was redesignated as Collins Hall in 1975.

The memorial fund was created by the reception of a single anonymous gift in 1970. Subsequently, the Collins family, all of whom are graduates of Cedarville College, determined to build the fund to the designated amount needed to create an education, business, and psychology facility from the 1923 building. The names of all eight alumni, including that of A. Roger Collins '19 (who passed away in 1975) are included in the list of contributors.

The family includes Dorothy Collins Hart '16, John '17 and Janet (McClellan '18) Collins, William '18 and Edith Collins, M. Earle '23 and Mary Collins, Robert and Pauline (Collins '25) Choate, James '28 and Ruth (Collins '28) McMillan, and J. Robert '31 and Lucille (Tanner '30) Collins.

The alumni association and the administration of Cedarville College deeply appreciate the contribution which this family has made to the ministry of Christian higher education at their alma mater. It is hoped that their dedication may be an example for others who share a concern for the future of Cedarville College.

LEACH PROMOTED

INAUGURATION TO BE HELD AT HOMECOMING

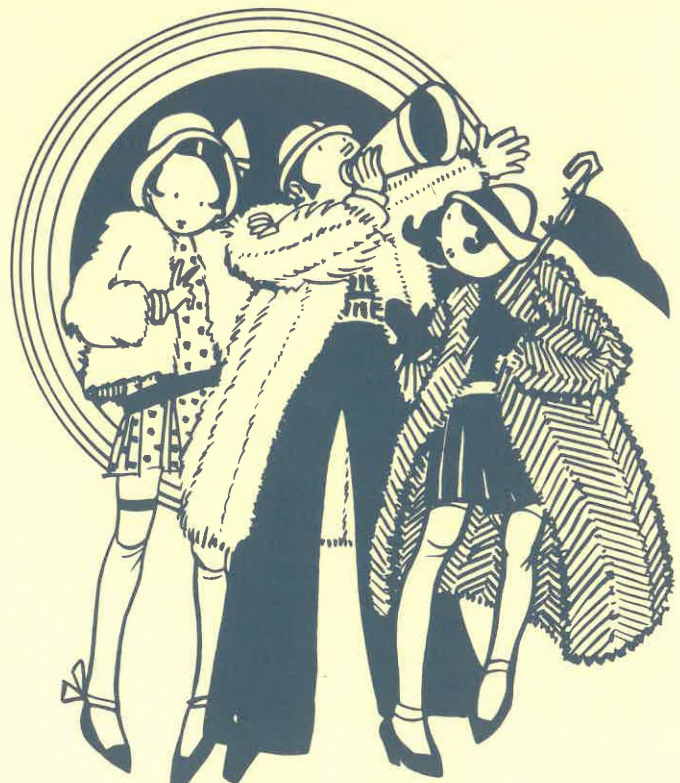
The inauguration of Rev. Paul Dixon as the president of Cedarville College will be held at Homecoming. The tentative schedule of events is as follows:

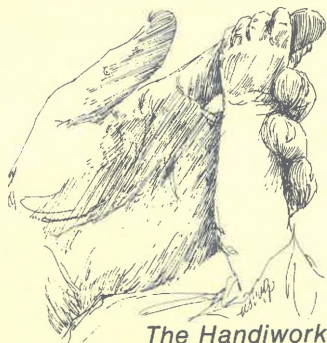
Hitching Post
