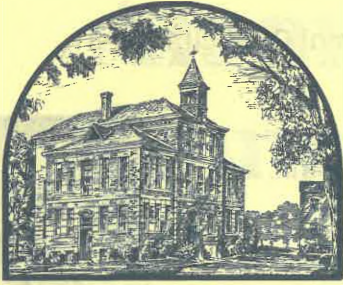

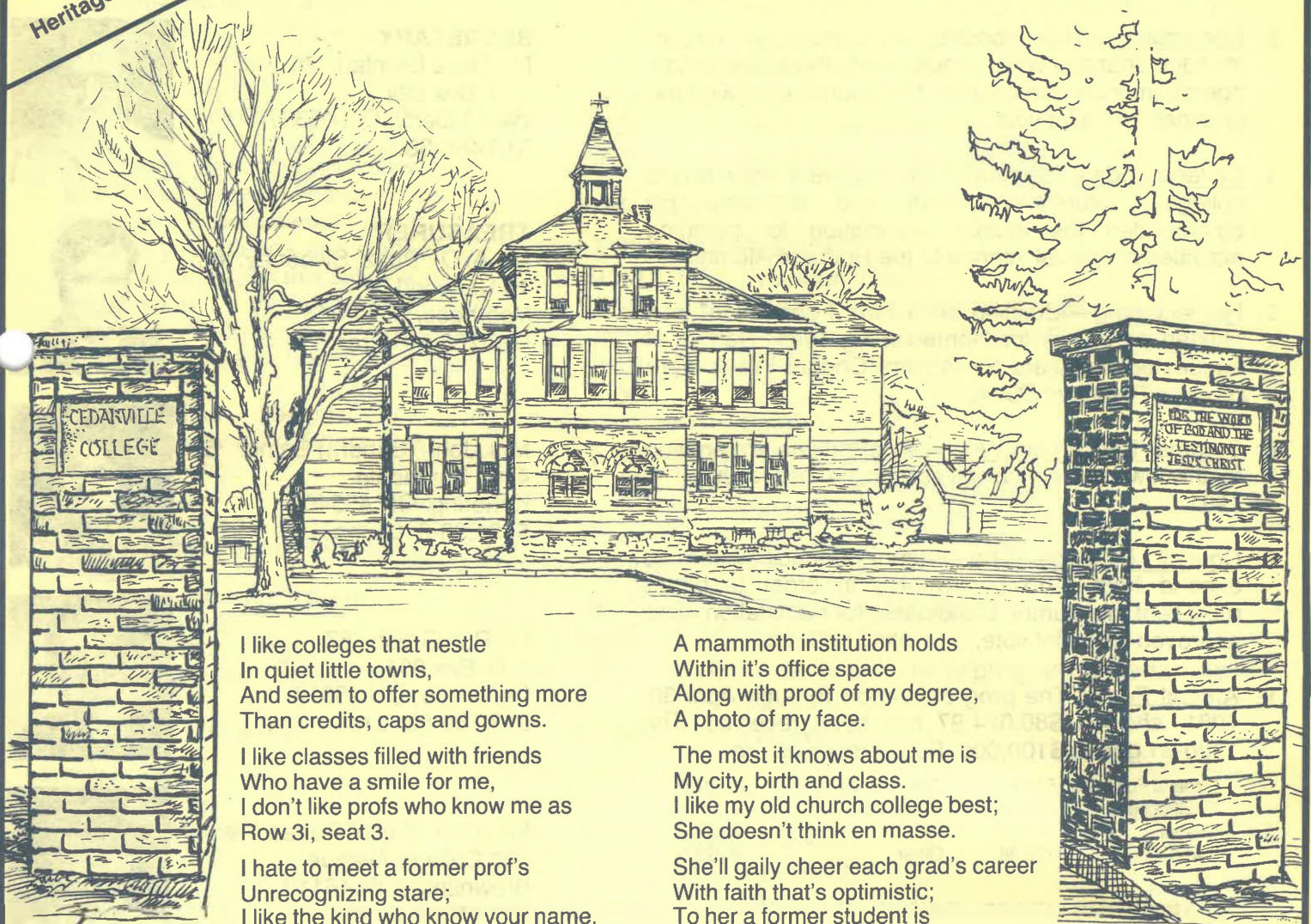

# ALUMNI COUNCIL REPORT

The following was on the agenda for the May 16, 1981 meeting:

1. Phonathon—A review indicated \$22,460 was pledged for the coming year by 511 alumni with an average gift of \$44. New Torch Club members totaled 86.
2. Alumni Scholarship Grant and Endowment Fund—Three \$500 awards were presented on Honors Day to students in the Education, Language and Literature, and Bible Departments. The fund is earning 12% and now totals \$11,245.14 after three years.
3. Constitution—The constitution committee recommended changes which would clarify the association's operation under the council. The council approved the changes for ballot vote.
4. College Update—President Dixon gave a report on the college's future enrollment and direction. He commended the alumni association for planning activities of special interest to the Heritage Alumni.
5. Homecoming—"Building on a Firm Foundation" was chosen as theme for Homecoming 1981. Names of suggested speakers for Alumni Chapel Week were given to President Dixon.
6. Summer Enrichment Week—Applications are arriving for this low-cost, enriching vacation planned for July 1-4, 1981.
7. Council Expands—The Alumni Council voted to expand from 7 to 8 members in order to better represent the alumni. Candidates for nomination were approved for ballot vote.
8. Annual Fund—The progress report through April 30, 1981, showed \$80,024.97 has been received. The 1980-81 goal is \$100,000. Funds received are:

## 1981-82 Budget Approved

At the April trustee meeting approval of the 1981-82 budget included a \$300,000 allotment for the remodeling of the current gymnasium into additional cafeteria facilities. An increase in student costs by an average of 10.2% comprised another portion of the new budget. The breakdown is 12% or \$6 per credit hour increase in tuition, a 5.9% or \$20 board increase per quarter, and a 10.5% or \$27 increase in room expenses.

Other proposals approved by the trustees included the addition of eight new faculty members, two each in the speech, education, and business departments, and one each in the science and English departments.

Authorization was also provided for the renewal of Pioneer Food Service's contract through the year 1981-82.



# Alumnae Coaches Successful

Much has been done in recent years in sounding the impacting voice of women in organized athletics. Their contributions have been often overlooked in a field which has been historically dominated by the male competitor.

When the progress of women's athletics is mentioned at Cedarville College, the name of Dr. Maryalce Jeremiah ('65) undoubtedly surfaces. Her influence as a coach at Cedarville has never been forgotten. Because of her strong convictions concerning the women's role in athletics, others have successfully followed her trail into athletic vocations. Maryalce is living proof of solid commitment toward the betterment of female athletics. She presently holds the post as head women's basketball coach at the University of Indiana. "Dr. J." maintains a consistent Christian testimony which has influenced hundreds of female athletes, including numerous Cedarville alumnae.

Cedarville College alumnae have not gone unnoticed in their quest to contribute in this rising field. Their coaching, medical, and administrative efforts have pervaded numerous colleges across the nation.

Coaching has become an avenue whereby women can use a vast number of abilities and talents. Miss Diana Jones ('76), often referred to as "DJ," has demonstrated her versatility this past year at Taylor University where she coached women's field hockey, basketball, and softball in her first year of active experience. She led her field hockey team to a third place seed in the Indiana state tourney. Diana, who recently obtained her master of arts degree in physical education, has attributed much of her early success to Dr. Jeremiah. "She taught me that teaching is a part of coaching. Some coaches lose sight of this."

It sometimes becomes extremely difficult to leave a place of dominant spiritual influence and then work under secular standards. Mrs. Sandy (Finch '75) Martin has gained a great deal of this insight at Kenyon College where she is presently the Assistant Director of Athletics and Physical Education. She has gained much respect, however, in her own portrayal of a positive Christian life. "It's difficult to see your impact in a basically humanistic environment. Sandy feels that her greatest acclaim to her profession is simply the fact that she is directly involved in athletics. She remarked, "Ten years ago most coaches were male." Sandy received her master's degree in physical education at the University of Dayton.

Miss Kim Gull ('78) has felt the pressures of a first-year coach at Geneva College. "I feel my greatest accomplishment has been to land a job

so quickly. It gives you a lot of confidence." Kim presently coaches women's tennis and is an assistant coach for women's basketball. She has seen her first year as one of planting seed spiritually. As a new coach, the feedback response is minimal. Her goals are soundly rooted in developing a quality program at Geneva. Much of this desire was instilled by coaches while at Cedarville. "They taught me that discipline, conditioning, and intensity are what builds an athletic program."

Much has been gained in areas of preventive medicine and athletic conditioning because of athletic trainers. Miss Connie Pumpelly ('73) is certified by the National Athletic Trainers Association and is currently a trainer at the University of Indiana. "I became interested in this aspect of sports because Cedarville didn't have a trainer while I was an athlete there. Also, a care and conditioning class aroused my interest." Connie works with all women's sports in practice sessions as well as rehabilitation of injured athletes. She also helps with the IU football program.

Dr. Jeremiah and Dr. June Kearney, as collegiate coaches, were professional influences on Connie's career. "They taught me that you have to be determined if you want something. You

## Cedar Day Queens' Reunion

"Other colleges have their Flag Day and their May Day, but Cedarville College has her Cedar Day. It is an institution peculiar to Cedarville College" (Cedrus 1916). Cedar Day is a day set aside in the spring of the year when the student body is host to the entire community. This year's activities included a morning road run, a picnic lunch by Cedar Lake, and special music by the Cedarville High School Band during the cedar tree planting ceremony and crowning of the Alpha Chi Sweetheart. Other events included a "legal" water fight among students and a fight against the village fire department for any group brave enough to face their hose. Horseshoe pitching, canoe races, and a myriad of other activities provided fun for the community and the college family.

The Alumni Association hosted a few special events of its own. Nearly a dozen former Rescue Squad members plus their wives were treated to a cookout, slide show, and viewing of the new Rescue Squad Ambulance—all planned by the present squad members.

The feature event for alumni on Cedar Day was the Heritage Alumni Salad Smorgasbord. After the tasty meal, the program began with a welcome by Gary Kuhn, Director of Alumni Relations. He quoted from the 1911 Gavelyte and used a slide presentation to pictorially display the Cedar Day Queens and Orators for each respective year. Ten former Cedar Day Queens made up nearly one-fourth of the 45 persons present. Each queen shared personal experiences of the day she reigned as Cedar Queen. A variety of tales were mentioned including the story of how the Hartman's milk cow ended up in the belfry of "Old Main." The oldest alumnus present was Mrs. Bertha (Stormont '11) Ferguson.

Several presentations were made that evening to the Alumni Association: Lucinda (Caskey '24) Whiteside presented a copy of the May 28, 1928, Cedar Needles; and Charles ('33) and Doris (Swaby '33) Spencer presented a 1930 Cedrus.

have to at least try." In consideration of that advice, she plans someday to move into a position of heading up an athletic training program.

Many collegiate athletes dream of returning to their alma mater in a professional way. Mrs. Sandy (Holwerda '75) Schlappi experienced that dream after the resignation of Dr. Jeremiah. She realized the immediate difficulty in filling the vacant coaching position; yet she felt prepared because of the teaching and coaching training she had received from "Dr. J." Sandy, currently working on a master's degree at the University of Dayton, feels that her greatest accomplishment thus far is teaching and coaching on the college level.

The battle of just getting recognition as quality personnel is slowly being won by women in the field of athletics. Coach Schlappi feels that this recognition has been an important factor in women's athletic success. "Girls are getting better opportunities now than those of the past. Skill levels are also becoming stronger." This progress has come because of quality coaches and other athletic specialists. Cedarville alumnae have shown their worth in this field and have reinforced the strength and quality of the Cedarville College physical education department.

# One Liners

The college Public Relations Department has added Miss Sheryl Liddle to their staff as photographer. Her work will include photography for news releases, advertisements, publications including the TORCH and AVISO, and a media slide production for Admissions.

Cedarville College qualified four students for the National Forensic Tournament held in Bowling Green, Kentucky.

André Michel Schub, the phenomenal pianist who has appeared as soloist with leading U.S. orchestras, performed on campus April 24 as a part of the college artist series.

Sixteen students have taken the television camera operation course offered by the Speech Department in cooperation with WFCJ-TV, Springfield.

The 1981 Student Senate In-Forum on Science, Scripture, and Creation featured Dr. Henry Morris, Director, and Dr. Duane Gish, Associate Director, of the Institute of Creation Research.

A new Students Health Awareness Committee (SHAC), comprised of ten students and two advisors, will represent the students' health-care needs.

Pastor Harold Green reports that nearly 40 students will travel to the mission fields of Australia, Brazil, and the Philippines this summer where they will be involved in a music ministry.

Literati, a rather new organization on campus, centers its activities on literature, music, and art and is designed to promote interest in these areas.

*Dramatized Bible Readings*, by Miriam Maddox, Associate Professor Emerita of Speech, is the culmination of eight years of work and presents selected scripture texts in a dramatized format.

On April 23, 1981, nearly 400 Jogathon participants were seen on the college track running or walking for the Student Body Project which raised over \$60,000 to be used for the new student center.

The 1981-82 catalog lists pre-engineering as a new field of study within the science major.

The nursing program scheduled to begin fall of 1981 is awaiting approval by the State Board of Nursing and the Board of Regents.

The Spring Enrichment Conference featured Dr. George Gardiner, Pastor of Calvary Church, Grand Rapids, Michigan.

Included among chapel speakers for the spring quarter were alumni Ernajeon Lockerbie ('61), ABWE, Bangladesh; James D. Jeremiah ('70), Pastor of Meadowbrook Baptist Church, Lima, Ohio; and De Elda Payton ('60), ABWE, Philippines.

Leaves of absence have been granted to Dr. James McGoldrick and Dr. Sharon Biddle to give them more time to work on books they are writing.

Senior and student body president Valde Garcia received the George C. Marshall Award "in recognition of attainment as the outstanding student in military studies and leadership" in the Army Reserve Officers Training Corps at Central State University. In June he and senior Brian Cafferty will be commissioned 2nd Lieutenants in the United States Army.

The 2nd annual Festival of Music, featuring compositions written entirely by students, was again a success. The 15-song program selected from 59 entries is available on tape through Christian Educational Publications.

At the 1981 Honors Day Chapel, the student body presented the Outstanding Faculty Member of the Year Award to Dr. David Matson ('60), Chairman of the Music Department, and the Outstanding Staff Member of the Year Award to Rev. Harold Green, Director of Christian Service.

# Cedarville College

## Alumni Association Constitution

### Article I—Name

The name of this association shall be the "Cedarville College Alumni Association."

### Article II—Purpose

The purpose of this association shall be the promotion of the interests of Cedarville College and the provision of Christian fellowship, information, education, and service opportunities to the glory of God.

The achievement of this purpose shall be the joint responsibility of the association and its Alumni Council in cooperation with the college development department.

### Article III—Doctrinal Position

This association shall subscribe to and uphold in principle and practice the doctrinal statement of Cedarville College.

### Article IV—Membership

Membership in this association shall include those who graduated from or attended Cedarville College since its opening in 1894 or Baptist Bible Institute of Cleveland, Ohio, prior to 1954. Those who have been awarded honorary alumnus status shall also be members of this association.

### Article V—Government

- A. Elections—shall be conducted by mail balloting for six-year terms on the Alumni Council with at least two vacancies being filled in rotation every two years. The nominating committee shall present more candidates than there are vacancies and shall provide opportunities for write-in voting. Council officers shall be elected from within the council membership by internal vote every two years.
- B. Criteria for Council Members—shall include a degree from Cedarville College or, prior to 1954, from Baptist Bible Institute of Cleveland, Ohio, and agreement with the doctrinal statement of the college.
- C. Nomination of Council Members—shall be conducted by a temporary committee appointed by the Alumni Council, chaired by a council member, and composed of at least six men and women (total of six) from the different classes.
- D. Duties of the Alumni Council—shall be to meet quarterly providing leadership and direction for the association and its activities; to appoint interim members to any mid-term vacancies of council members; to file annually with the director of development and the director of alumni relations a written evaluation of the effectiveness of the alumni program and staff; and to serve as the Alumni Development Committee of the college.
  1. Chairman—shall chair and provide creative leadership of the council in fulfilling the objectives of the association meetings and programs; and monitor the activities of director of alumni relations and his office.
  2. Vice Chairman—shall be acquainted with and prepared to assume the duties or position of the chairman in his absence, and assist the association and chairman in their functions, activities, and plans.

3. Secretary—shall record minutes of each council meeting and assist the association and chairman in their functions, activities, and plans.
4. Treasurer—shall assist in the recording and maintaining of association fund raising records and monitor the Association response to alumni donors and nondonors.
5. Director of Alumni Relations—shall be an ex-officio member of the Alumni Council and shall periodically submit summaries of his activities and observations to the council. He shall be a member of the college development department staff and be responsible to the director of development. He shall be mutually selected by the Alumni Council and the director of development.
6. Director of Development—shall be an ex-officio member of the Alumni Council and chair the periodic Alumni Development Committee meetings.
  - E. Advisory groups may be organized as need arises at the discretion of the Alumni Council.

### Article VI—Association Meetings

- A. The association shall sponsor the informal and any formal activities connected with the annual fall homecoming.
- B. The Alumni Council may call for a special meeting by written communication, or one may be requested by a petition signed by twenty-five members with alumni status. In the latter case, the entire association membership must be notified at least one month prior to the scheduled meeting.
- C. Any other meetings, activities, or system of such deemed conducive to fulfilling the objectives of the association and the college may be instituted upon recommendation of the Alumni Council.

### Article VII—Finances

All financial matters of the Alumni Association such as budget, expenditures, and records shall be maintained by Cedarville College in consultation with the Alumni Council.

The Council shall have access to alumni records at all times and shall receive an annual report for communication to the Alumni Association.

### Article VIII—Publications

Various materials and publications shall be supplied to the association membership periodically and free of charge. These items may be altered, discontinued, or replaced at the discretion of the college and the Alumni Council. These shall be largely the responsibility of the director of alumni relations.

### Article IX—Awards

The Alumni Council shall administer the regular and/or occasional conferring of awards of various types to individuals having contributed to Cedarville College in meaningful ways.

### Article X—Amendments

Amendments to this constitution or adoption of a new constitution may be enacted by a majority response to a mail balloting.

The Alumni Council of Cedarville College has undertaken to update the phraseology of the association's constitution, such as executive committee to alumni council and alumni coordinator to director of alumni relations. The only substantive change made is the deletion of the office of immediate-past president. That office became obsolete with the inauguration of the rotating council format four years ago by association ballot. A copy of the previous constitution is available in the 1979 Alumni Directory. Please read the constitution carefully and indicate your approval/disapproval of these formalities on the form provided.
