#### **HOMECOMING 1982**



In 1938 Roy N. Linton graduated from Cedarville College with a bachelor of arts degree – at the age of twenty – while more than giving promise of the drive and leadership which would urge him to excel. Majoring in mathematics and planning to teach, he still found time to serve as president of the class of 1938 and participate in a number of extracurricular activities, among which were two years of intercollegiate baseball and three years of basketball.

After attending The Ohio State University, Mr. Linton taught math and coached basketball in Ohio at the Blanchester Heights High School. In 1941 at the outbreak of World War II, he entered the United States Army, in which he served until the 1945 end of the hostilities, emerging with the rank of major.

## Alumnus of the Year Award

After a term with the Dayton branch of the Veterans' Administration, Roy Linton entered the Standard Register Company in 1947 as a sales representative in the San Diego district. Managing several regions from 1951 to 1969, he became a director of national marketing. Appointed vice president of operations in 1971, then executive vice president, Mr. Linton became Standard Register's president and chief operating officer in 1977 and president and chief executive officer in 1981. He has been recognized for his contributions to the American business community by an entry in *Who's Who in America*.

Roy and Joyce Linton, the parents of two sons, remain active in their fellowship with and participation in the Fairhaven Church of the Christian Missionary Alliance in Dayton.

Having returned to the region of his collegiate days and mindful of his background, Roy Linton continues to support Cedarville College in deed and in work. In his own words he recently observed of Cedarville College that "the Christian environment nurtured the growth of eternal values which have enabled me to relate realistically and tolerantly to a wide spectrum of social and cultural values and to cope satisfactorily in a competitive and changing society without eroding my spiritual values."

By this citation the Cedarville College Alumni Association hereby expresses its appreciation to God for His work in and through Roy N. Linton for the quality of his life and for his sense of his Christian education heritage, thus naming him 1982 Alumnus of the Year.




## **Honorary Alumnus Award**

Charles E. and Betty J. Tarter have faithfully served the college in various capacities. Born in nearby Jamestown and raised in Xenia, Charles E. Tarter served in the United States Army before operating his own service station. The day after Christmas 1959, he joined the Cedarville College staff to assist Gerald "Pop" Marshall with the maintenance and cleaning of the college dorms and classroom buildings. Nine months later he asked his wife, Betty, if she would be interested in temporarily filling the vacant position of cook in the college cafeteria. She accepted and these two individuals have touched the lives of numerous Cedarville students, having invested nearly a quarter of a century each serving the Lord in a quietly competent fashion on the campus of Cedarville College.

Charles became assistant director of physical plant in the late 60's and in June of 1974 assumed the position of director. With Cedarville's growth came the need for a security director, and Charles filled those shoes as well. He spent many solitary nights watching over the college domain and its prank-minded family. Charles recently retired with twenty-three years of dedicated service.

The elder of her parents' two daughters, Betty also grew up in Greene County south of Xenia where she helped on the family's farm. She married Charles in February of 1956 and assisted him daily in his business. Betty was asked to stay longer than the initial two weeks at Cedarville College and became manager of the dining hall. ## Moody V.P. - Don Leach

A Cedarville alumni council member, but also vice president and treasurer of Moody Bible Institute, Chicago, Illinois, Don Leach spent his freshman year of college at Bob Jones University, Greenville, South Carolina. Feeling that the Lord placed him at Bob Jones University for a year to learn effective study skills, Don transferred to Cedarville in 1964. Don believes that his switch to Cedarville College took place through the Lord's leading, because at that time few people from his home town area of Long Island knew about Cedarville College. Also, it provided him with an opportunity to play

Don was a member of the Varsity "C" Club and also participated in intramurals. A full-time job and his engagement to wife Nancy (Davis '68N) during his junior year left him little time for other activities.

Originally a member of the class of 1967, Don did not graduate until June of 1968. He spent the year of 1967 in the army reserve. After his graduation, the Leaches settled in Dayton where Don worked for several companies for the next fourteen years and also earned his M.B.A. from the University of Dayton in 1974.

After first working for Top Value Enterprises, Inc. as a tax accountant, Don then spent 14 months with Philips Industries as a tax analyst before joining Danis Industries Corporation. During his nine years with that company, he successfully filled

the positions of tax manager, internal auditor, and assistant vice president in charge of tax and internal audit, spending his last four and one-half years with Danis as vice president and treasurer. The Lord was blessing the Leaches financially and spiritually. They were involved in the work at Washington Heights Baptist Church, Dayton, Ohio, and, thus, Don never had any serious intentions of getting out of the business world. Two and one-half years ago, however, he began to realize that his priorities were out of focus, that his career was number one, with God and his family running an interchangeable second and third.

He states, "As I began to spend quality time in God's Word, He dealt with me and showed me that my career could not be number one. I realized God is concerned with how I measure in terms of His Word and its application to my life – not how I measure in the corporate ladder."

Don began reevaluating his career objectives and thought that God would want to use the career traits he had developed over the years. In May of 1982, Don began his work as vice president and treasurer of Moody Bible Institute.

According to Don, his new job is a "real change in careers," but he finds the work exciting. He and Nancy and their three children: Donny (11), Brian (10), and Debbie (3½), are actively involved in Faith Baptist Church, Wheaton, Illinois.

Mr. Leach's position puts him in charge of Moody's 125-member treasury branch which oversees the accounting department, the controller, internal auditing, constituency service, and information systems; and with all of those, Don declares, "There's never a dull moment." As chief financial officer, he carries the responsibility for the school's financial well-being, which includes Moody Press, *Moody Monthly*, Moody's Institute of Science in California, Moody's Christian day school ministry in St. Petersburg, Florida, its aviation school in Elizabethan, Tennessee, and its correspondence courses in which 60,000 participate.

Don and his family think it is tremendous that they have found "that good and acceptable and perfect will of God" (Romans 12:1,2).

## **Alumni Return**

Excitement to be back on campus and enthusiasm for the coming year seem to be the prevailing attitudes of four new faculty members.

Jim Leightenheimer, assistant professor of broadcasting, returns to Cedarville in a teaching capacity. He is not a new-comer to his field, having worked at WCDR while pursuing a double major of speech and broadcasting. After graduating in 1980 he worked as director of public affairs and announcer at WFCJ radio in Miamisburg, Ohio. He will be teaching Audio Control Techniques and Broadcasting while pursuing his M.A. degree at The Ohio State University.

Teaching health education and physical education courses, as well as coaching volleyball and softball, is Elaine Brown. "My professional and personal goal when I left in 1977 was to return to Cedarville," stated this graduate, who also

gained her M.S.Ed. degree at the University of Dayton. A native of Gallipolis, Ohio, Miss Brown taught and coached four years at Middletown Christian Schools. She plans to begin pursuit of her doctorate next summer.

Supplementing a well-established social science department is Dr. Rex Rogers ('74), new assistant professor in political science. Rex gained his M.A. degree at the University of Akron, then spent three years at the University of Cincinnati, successfully defending his dissertation on county government reorganization. Specializing in state and local government, public administration and urban politics, Rex purposely geared his studies for teaching on the collegiate level. His goal was fulfilled in stepping into his position here.

Another graduate returning to campus as a lab instructor for the science and mathematics department is Julie (Marihugh '80) DeLange. Julie taught high school math and science for one year before working in the laboratory at the Kettering Medical Center. She hopes to improve her teaching abilities and ease the work load of other department members as she teaches Introduction to Math and instructs labs for Introduction to Biology.





Sixty-two students, faculty, and staff recently made the annual trip sponsored by the Department of Language and Literature to Stratford, Ontario, for the Stratford Shakespeare Festival, where they viewed four plays.

Director of Placement David Gaffner ('69) reported an excellent turnout for the first Career Day. Five alumni were among the representatives from nearly 50 companies who presented job opportunities for Cedarville College graduates.

Leadership Conference '82 was sponsored by the Student Senate. This three-day conference was designed to build leadership and communication skills in the lives of Senate members, class officers, dorm representatives, and other student body leaders.

Pastor Kimber Kauffman ('80) and his brother Reese, president of Kauffman Products, Incorporated, Carmel, Indiana, were the featured speakers at the Swordbearers Conference. They addressed the theme "Laboring for the Lord."

Two sacred vocal concerts, part of the 1982-83 College Artist Series, featured Diane Susek and Christine Wyrtzen.

The fall drama production of Gilbert and Sullivan's "Ruddigore" was directed by faculty member David Robey. This tongue-in-cheek fairy tale set to music involved more than 60 students including nine leads in its four performances.

Over 300 phones have been installed in Lawlor and Printy Halls which increase the quantity to nearly 700 dormitory phones on campus. Student room fees cover the local and monthly service charges and long distance calls are billed directly to the student by Ohio Bell Telephone.

Thirty seats plus more space for current periodicals have been added to the college library by remodeling the former media auditorium classroom. The room is used for current and bound periodicals, microfilm readers, copiers, and library files.

"Welcome to 1926" was the theme for the Homecoming Royalty Banquet, at which time Miss Deborah Buining of Des Moines, Iowa, was crowned 1982 Homecoming Queen.

Two weeks of chapel during October were set aside for faculty and staff panel presentations on the objectives of Cedarville College as stated in the college catalog.

According to Barbara McIntosh, Director of Academic Records, there are 555 freshmen, 411 sophomores, 369 juniors, 368 seniors, and 27 special students, bringing the fall 1982 enrollment to 1,730 students.

Cedarville College has 74 full-time faculty who hold degrees from 97 colleges and universities including 20 different Christian colleges and seminaries.

"Baskets of Thanksgiving" was the theme of this year's Community Night, November 23, with an evening of free basketball. Donations of canned and boxed food items were collected and distributed to 20 families in the Cedarville community in time for Thanksgiving.

All sixth-through twelfth- grade basketball enthusiasts are encouraged to attend coach Don Callan's 1983 Yellow Jacket Basketball Camp, July 25-30, 1983.

The snack shop is now located in the Student Center – second floor of Athletic Center – and offers students a unique variety of delicious foods having the distinct character of a New York delicatessen.

## C.C. Grad Gets Grant

If you asked Stu Walker, 1971 graduate, what he has been doing lately, you might see a twinkle in his dark brown eyes as he gives you an off-hand answer: "Studying the rickettsial interaction with endothelial cells and platelets." After you recover from that answer, he will explain that actually he is trying to find a vaccine for the prevention of typhus and a treatment for the symptoms of this disease. Yes, some day the name Stewart Walker may go down in history as the man who discovered a vaccine and cure for typhus. The National Institute of Health must believe that is a distinct possibility, for they have given Dr. Walker a grant for \$168,000 to study Rocky Mountain spotted fever and typhus. Stu carries on this work at Ball State University in Muncie, Indiana, where he is assistant professor of biology and an adjunct assistant professor of microbiology at Indiana University School of Medicine.

If you followed the trail of Stu's life that led him to this position, you would find that after graduation from Cedarville College in 1971, he and his wife Andrea (Houchin '72) went to Indiana University where Stu earned master's and doctorate degrees. God moved the Walkers to Charlottesville, Virginia, and to Mobile, Alabama, to complete the studies and back to Muncie, Indiana, where Stu now works.

This young scientist does not spend all his time, however, looking through the lens of a microscope. He is busy in the service of the King. Stu and Andrea take an active part in Real Life Ministries. In this program, the Walkers are reaching out to students on the campus of Ball State University. They are reaching them with the gospel of Jesus Christ as they hold Bible studies on campus. God is blessing the effort. "Last year we had six to ten in attendance at the Tuesday night rallies. This year we have around 20 and have had as high as 32." Stuexplained. They encourage these students to attend church on Sundays, and if they do come to Grace Baptist Church in Muncie, they will see this serious-minded scientist as the teacher of the young adult Sunday school class.

"I'm thankful for the preparation I received at Cedarville College," Stu said during his visit Homecoming week. "I have thought many times how thankful I am for the way the professors of the science department prepared me for my work. They toughened me up for the competition and aggressiveness of graduate school and later a career in science." But Stu was thankful for more than just the preparation in his major. "I never dreamed how the Lord would use many of the classes I took at Cedarville College," Stu added. Since leaving Cedarville, Stu has served as choir director, soloist on television, choir member, Sunday School teacher, and has worked in radio. "God has used teaching and music as my main areas of service, and Cedarville provided the training in those areas."

Stu shared with the 1,730 students and faculty during his chapel message Homecoming week that he had made decisions while at Cedarville College that have influenced his life in later years. He challenged them with the following criteria for making decisions: "Thy Word is a lamp unto my feet and a light unto my path." Surely, God has led this Cedarville College graduate down a path that has brought glory to His name.
