Miss Bernice Mick ('55), like nearly every Cedarville College student, began her senior year praying earnestly God would show her where she could best serve Him. The answer came in December 1954, before her June graduation, when Dr. Jeremiah approached her with the opportunity of managing the campus book room. Although not the answer she expected, after a time of prayerful consideration, Miss Mick knew it was what God wanted her to do. "When God called me to this ministry, He gave me a real burden to get good Christian literature into the hands of people."

Bernice Mick was born and raised in Clendenin, West Virginia, and came to know Jesus Christ as her personal Savior during her teens. After her graduation from high school, her father died and she helped support her mother and seven brothers and sisters. She gained a great deal of general merchandising knowledge during the 17 years she worked in a drugstore.

Then the Lord called her to go to Bible school and into fulltime Christian service. Beginning her schooling at Baptist Bible School in Johnson City, New York, Bernice transferred to Cedarville College in 1953 to be closer to home. She enjoyed teaching a

Sunday School class and working with a young people's group on Sunday evenings and thought that perhaps this was the type of ministry God was preparing her for. "It never entered my mind I would be in store business again," she remembers.

When Bernice arrived at Cedarville College in the fall of 1953, there was no bookstore on campus. Books were purchased at one of the windows of the Business Office. In 1954 Don Collins, the purchasing agent, set up files, a desk, and a few shelves on the south side of the Business Office where the switchboard and reception area are now located. This is where, in 1955, Bernice began her bookstore responsibilities.

In 1956 the bookstore was moved to the basement of the Andrew Carnegie Library (Fine Arts Building). Here Bernice was also in charge of the snack shop, student lounge, and laundry room. The next move was to Patterson Hall in 1959. Originally a two story building, Patterson

housed the bookstore, snack shop, and student lounge on the first floor and dorm rooms on the second floor.

Due to increased enrollment and the need for more dormitory space, the bookstore moved to Milner Hall in 1962. In each location Miss Mick used every possible square inch that was given to her.

The main purpose of the bookstore is to serve the faculty, staff, students, and alumni of the College. But through the efforts of Bernice Mick and her servant's attitude, the bookstore is also a storehouse of ideas and resources for churches, pastors, missionaries, and laymen across the United States and in many parts of the world. Bernice has also helped other bookstores get started and has made Christian literature readily available to many through retreats and seminars.

Reflecting on her 33 years of service at Cedarville College Bernice states, "God has done great and wonderful things for us, whereof we are glad. It has been a great thrill and blessing through these years to see God at work. I am thankful He called me to this ministry of Christian literature."

Bernice Mick was recognized for her special ministry by the Alumni Association in 1969 when she was named Alumna of the Year, and in 1978 when the **Miracle** was dedicated to her.

May 19, 1986 was declared "Bernice Mick Day" in recognition of her record 32 years as a staff member and her retirement. She was given a plaque and a book of letters written by many friends and co-workers to thank her for her service and friendship. Miss Mick has retired from her work at the bookstore at Cedarville, but not from the ministry to which God has called her. She anticipates new avenues of service in her new home at Maranatha Village in Sebring, Florida.♥

Teaching But Still Learning

Kathy (Howell '76) Sturgis this spring completed a decade as Director of Swordbearers with plans to begin a new ministry. She and her husband Barry ('86) are anticipating the birth of their first child in December, and Barry has accepted a teaching position in South Charleston, Ohio.

Kathy was a preacher's kid who sang her first solo at the age of four. She was saved at the age of seven at a musical youth rally. After high school, Kathy attended Moody Bible Institute and traveled with Moody Chorale for two years, graduating in 1973 with a diploma in Church Music.

Kathy's goal in life was to be a concert musician, and she sought further training at Cedarville. She recorded her first solo album, "How Wonderful Thou Art," in 1975 and was involved in Abundant Life, Concert Chorale, and Australia Missionary Internship Service (MIS). She was also the Assistant Director for Concert Chorale under Dr. David Matson. Pastor Green offered her the position of Director of Swordbearers in 1976. During 1976-1978, Kathy traveled on the weekends to solo concerts.

As Kathy planned to record her second solo album, her vocal chords and throat began to give her problems. There were times when she could not even talk at all; she recalls training teams without speaking to them. This great change of direction caused her to realize that there was more to her ministry than singing. By training teams she was multiplying her own ministry. Kathy began learning from and with her students. She learned

"If there is ever anything that I can do for you just let me know." Little did Paula (Weekley '75) Bussard know that this friendly statement would lead her to a position requiring fifty to sixty hours a week as the executive director of the Christine Wyrzten Ministries (C.W.M.)

Paula met Christine Wyrzten in 1976, the year after she and her husband, Larry graduated from Cedarville College. Through sharing each other's joys and sorrows in letters, Paula and Christine befriended one another. Casually, Paula mentioned that she was willing to help Christine

how to mix music and fun and began to feel comfortable teaching.

The turning point of Kathy's difficulties vocally came while attending a four-week music seminar, where she discovered that she had been using her throat muscles incorrectly. After being taught proper use of those muscles, she was again able to sing. However, her goal of a concert musician had changed to teaching and multiplying her ministry.

In 1981 Kathy met her future husband, Barry L. Sturgis, who was on one of her teams. They were married November 20, 1982. Kathy states that she has learned a great deal from their relationship; Barry has demonstrated patience, kindness, and sensitivity to others. Kathy feels that she can, with these qualities, also enhance her ministry through counseling.

Kathy's future seems to hold as much of a learning experience as her past. She would like to serve the Lord not only as a wife and mother, but also through music in the church. Looking back now, Kathy realizes that God has used her talents for His service, but in a very different way than she had planned.

with C.W.M. in any way she could. Soon Paula began working two or three hours a week, with duties ranging from answering letters to helping with concert details. As C.W.M. grew, so did Paula's duties.

At present Paula's job is two-fold. She is both head of the administrative staff and co-developer of products. As head of the administrative staff, Paula supervises ten people. Her

Aside from Critter County, Paula is still a busy woman. She tours with Christine, assisting her with concerts, co-produces Wyrzten recordings, and writes lyrics. Paula is currently working on a Wyrzten/Bussard Women's Seminar.

Looking back at her Cedarville College experience, Paula can see how God had prepared her for this present ministry. A communications arts major, she could never see herself on the stage giving speeches, but had thought of a teaching career. Now Paula sees what God had in store — operating backstage for Christine.

Much of Paula's success comes from her work attitude. She considers her work her hobby, and her boss her friend. This combination makes her work fun. A larger part of Paula's success, as well as that of C.W.M., is the idea that "we need to look at each other and our talents the way that God looks at us. He has given us different abilities, but all that really matters to Him is our faithfulness in honoring Him with our gifts. It is indeed an encouragement to see how God can meet needs when we simply say, 'Is there anything I can do?'" ■

The Christian Ministries Department provides numerous opportunities for students to apply their classroom learning. Rev. Harold Green, director of the department, compares the ministries to a learning laboratory as he states, "Our purpose is to allow students to experience first-hand the principles taught and challenges given in the classroom."

Cedarville College places a high priority on Christian ministries, as it is the only Christian liberal arts college to give the Christian ministries director full administrative status. Pastor Green states, "We put Christian ministries on an equal relationship to the academic areas. The doing is as important as the learning." With this support the Christian Ministries Department has grown and developed in several areas.

Christian Ministries began as a part-time program under the Student Services Office. As the school grew, the outreach programs expanded. Pastor Green became the campus pastor and director of Christian ministries in 1970.

Kevin Smith serves as the assistant director, coordinating the music for the Abundant Life Singers, Kingsmen Quartet and Sounds of Joy trio, as well as special music for chapel and the

Campus Fellowship on Sundays, James Cato ('83), formerly the field representative and announcer for the college radio station WCDR, is now the director of Swordbearers. In this position he chooses, trains, and supervises all of the traveling Swordbearer teams, as well as the fifteen Swordbearer extension teams which consist of two to six students who serve at a specific area church every weekend. In addition, he coordinates the annual Swordbearers' conference.

Kirk Keller ('83) is the director of the compassion ministries and Master's Puppets ministries. Compassion ministries include visiting senior citizen homes, detention homes, jails, hospitals, homes for the mentally retarded, orphanages, and other local college campuses. The puppet ministry involves helping students write and produce scripts as well as presenting them in local churches.

The office also has three secretaries. Margaret Green works as her husband's personal secretary and is responsible for the Missionary Internship Service. Cheryl Miller ('83) sets up the itineraries for the gospel teams and coordinates the details for the compassion ministries, and Virginia Fields ('84) works for nine months of the

year as an assistant to Margaret Green in the MIS division. Together, these people coordinate over 60 ministries and the MIS program.

Over 1290 students participate in various ministries, although Christian service is not mandatory at Cedarville. In 1971 Cedarville withdrew the requirement of two years of Christian service, but instead of dropping, student participation increased from 61 to 71 percent. Pastor Green explains that he challenges the students based on their love for the Lord and the joy of serving Him.

The Christian ministries are divided into compassion ministries, gospel teams, The Campus Fellowship, and MIS. The outreaches to the detention homes and jails, which are typically difficult ministries, have been very successful. This past year those that were saved became grounded through the follow-up programs. Spring Break teams, such as recent ones to New York and Utah, use direct confrontal evangelism and have also had good results. "The visible results are not the only benefits." Pastor Green emphasizes. "The ministries also add to the stimulation of growth in the students who participate."



The Missionary Internship Service is another major ministry of the department. It gives students, faculty, staff and alumni the opportunity for a short-term ministry on a mission field as an individual meeting a unique need, or as a member of a singing, puppet, or athletic team. Since its beginning in 1970, the MIS program has sent 953 participants to 38 foreign countries and the U.S. raising over \$1,393,125 in support.

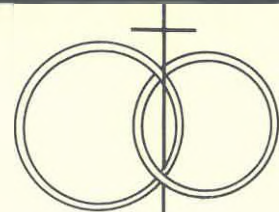

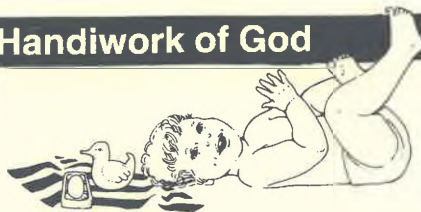

responsibilities include overseeing the Critter County radio program and helping others by showing compassion and encouragement through letters and counseling.

The most obvious of Paula's accomplishments as co-developer of products is the Critter County series. Critter County is a multimedia of animal stories, books, tapes, puzzles, cards, stickers, and worship programs designed to help children learn Bible verses.

Critter County began about two years ago while Paula and Christine were trying to teach their children Bible verses. Paula thought that a creative way to make memorizing fun would be to put the verses to music. This idea led to Christine's first Critter County album and has become a very large ministry to children

having reached over 500,000 youngsters.

Seeing the growing demand, Paula soon began writing books, which now total twelve. Each book emphasizes a different Bible verse and shows how to apply it. The books come with stickers and a cassette so children can read along. Just released in January is a thirteen week curriculum of Critter County material for the classroom, youth group, or summer camp. Ninety--five radio stations air the fifteen minute broadcast every week, with plans for expansion. One of Paula's goals for the Critter County concept is to see it teach Biblical principles to children through the secular market. She is currently in negotiations with Capital Records, Procter and Gamble, and Kenner Toys to see this potential dream realized. ■

He and his staff organize set-up, menu and service in the dining room in addition to their regular responsibilities in the cafeteria. In keeping with the president's philosophy of guests experiencing the campus atmosphere, guests in the dining room are often served the same meals served in the cafeteria.

Total cost estimates are not complete as yet. The generous gifts of Pioneer College Caterers and a few private individuals accomplished project financing.

College guests truly do have a new and larger menu from which to choose. The new President's Dining Room allows guests to taste style, elegance and entertainment, all served with Cedarville hospitality. ■

Pastor Green explains the MIS endeavors not only to introduce the student to missions in a hands-on experience where God can speak to him, but also to allow the student to determine whether or not missions are for him. Pastor Green points out, "Preventing casualties on the mission field is just as important as giving a call." Even if the student does not become a missionary, the experience gives him a burden for missions.

The results on the field vary, but most of the missionaries respond that the greatest impact is the doors opened by the team. Pastor Green adds that MIS teams will contact more people in a short period of time than the missionaries could reach in nine months.

Cedarville's MIS program is unique. If a student has not raised his total support, the

College still allows him to go, paying the bills until the participant raises the funds after he returns.

Cedarville College believes that the money invested in MIS and other Christian ministries reaps tremendous benefits in students' lives. Pastor Green states that the dividends come when the ministries build character into the students' lives causing them to continue as productive Christians after they leave Cedarville. He states, "The best part of the job is helping a student grow and establish himself spiritually." These dividends are part of the motivation for future growth. Pastor Green adds that they are constantly challenged to look for new areas to serve the community and county in order to give students even more opportunities to turn their theory into practice. ■
