STUDENTS ON TELEVISION

The Phil Donahue TV Show invited two Cedarville College students to appear and discuss, "Two Views of Life." This hour long program is seen daily by over 80,000 homes in the greater Dayton, Ohio area and is ranked the No. 1 daytime show. Mr. Donahue invites guests from every facet of life who are making news by being unusual. After a short discussion and interview the television audience may phone in questions. There were approximately fifty studio audience guests as well as twenty Cedarville College students.

Since we were guests last September, the uniqueness of Cedarville College was briefly known by his regular audience. Our second appearance was February 26, when Kenneth Muck and David Kearney discussed their views of life with those of two Antioch College students from Yellow Springs, Ohio.

In general the students of Antioch "do not share Cedarville's views as to their rigorous discipline, lack of freedom, repression, and closed environment." They felt that Cedarville "does not have natural freedom." The Antioch College guests could not understand how we could "give the responsibility to others to take over for you." "You use God as a crutch; the Bible is not necessary; I don't see how it has done anyone any good; it is outdated;" were statements from the Antioch students who also said, "humanity is unhappy and dissatisfied."

Further discussion was whether or not there was a God. One Antioch student said, "there is something in my life that I call a god, but no person." The explosion theory was their explanation for the origin of the world. Since the reality of God was not important to the Antioch students they stated that "we like to ask the questions, not answer them."

Ken and Dave through their personal testimonies, left a concrete, tangible and real basis for their convictions in the person of Christ for their faith — "Cedarville College is preparing men for service to help others for eternity by not letting them go to Hell."

Pastors are encouraged to mark their calendars and plan to be with us for the second annual pastors' conference, September 8 - 11. Dr. John G. All meals and lodging will be provided free of charge by the college. Churches can encourage their pastors to attend by providing transportation expenses for them.

FROM THE PRESIDENT'S DESK

Dr. James T. Jeremiah, President



As we seek to evaluate the program and progress of Cedarville College, there are many encouraging successes which challenge us to press on toward new victories.

Last year our elementary and secondary education program received full approval with the exception of physical education. On March 10 this teaching field was also approved. Another area of music education was also granted approval by the State Department of Education. This means that young people in our churches may consider Cedarville College as they prepare to teach in Christian, elementary, and secondary schools, as well as in the public schools of the state. Although this full approval has been in effect for a year, these additional areas of recognition will appeal to a great many.

We expect another major project to be underway by the time you are able to read this announcement. For many months we have been working toward the time when we could begin construction of our athletic fields, including track, soccer field, baseball diamonds, and tennis courts. Since this program will involve moving tons of dirt, we will be able at the same time to construct a six-acre lake without much additional expense. A number of facilities for use by our students will be created by this construction. Before the project is completed it will cost nearly \$100,000. We are looking to you, our friends, to help meet this need and supply funds which will make these new student facilities a reality. It should be pointed out that during the last two or three years the students themselves have been instrumental in raising \$6,000. This is evidence that these facilities are not only needed, but our students sincerely desire them. As usual, they challenge the rest of us by their interest in their college.

We are living in the space age. New scientific achievements are being made almost every day. Christian young people must be challenged to become acquainted with these advancements that are so much a part of our generation. As a Christian liberal arts college, we are endeavoring to emphasize the importance of science; not only in the general education of our young people, but in a major emphasis which will prepare them to serve as science teachers and qualified people in many other scientific areas.

To accomplish this purpose of preparing young people to face this scientific age, it is imperative that we provide the best equipment possible for their use in these college days. For this reason we are planning as soon as possible to provide better housing and equipment for our teachers and students in the science department. It has been stated by many that our building and equipment are totally inadequate. All of us on the Cedarville College campus agree, and we intend to correct this deficiency as soon as possible.

A new building and equipment will be costly. We cannot provide such a unit by the sale of bonds or by borrowing money from the bank because it is not an income-producing facility. We must then depend upon our churches and our friends to meet this need. Your gifts now and in the future, designated for a new science building will be much appreciated.

This fall a special campaign for a new science facility will be launched with a special appeal to the churches which have such a vital interest in Cedarville. We are asking that pastors and the boards of our churches give due consideration to participation in this financial drive, encouraging our fine science faculty by providing better equipment with which they can work. **Pastor, somewhere in your calendar for the next year, please put a notation for a special emphasis upon the science program at Cedarville.**

The next time you visit the college, we will be happy to greet you in the attractive reception lounge located in the administration building. It features a new ceiling and paneling revealed in the picture on the left. The area will soon be garnished by new drapes and furniture. The general business office and the academic dean's office are also nearing completion.

The seventeen faculty offices pictured on the right are nearing completion. Partitions are up, air-conditioning is installed, and carpeting and new furniture will soon grace these offices.

The trustees have authorized work on the new lake, tennis courts, and athletic fields. We trust work on this project will have begun by the time you receive the bulletin.

A campaign will be launched this fall to raise funds for a new science building. This is the first major fund drive the college has embarked on since three years ago when churches and friends of the college helped make the new library building possible. We ask you to pray that we may have the Lord's direction and blessing upon this effort.

1968-69 Political Science Class

A class project was conducted with five hundred area residents in a survey on Greene Joint Vocational School. Professor Allen Monroe said this was done entirely as an educational research project. Six questions were asked and then the questionnaires were run through a computer for a summary as to support and non-support for the GJVS.

CHURCH TOURNEY TALLY

The Varsity Club held its annual church basketball Junior Tournament on February 28 and March 1; the Senior Tournament was March 7 and 8th. When it was all over Grace Baptist Church of Middletown, Ohio had taken six of the ten trophies awarded in both tourneys.

YELLOW JACKETS WENT TO FIRST ROUND NAIA



Cedarville's final season record was 16-11. Ohio Northern and Cedarville battled it out March 3rd for the shot at Kansas City, but the jackets never got warmed up and it ended with 101-78. Congratulations are in order for Dr. Donald Callan and his "Yellow Jackets" in winning the Co-Championship of the Mid-Ohio Conference. We share this honor with the "Yellow Jackets" of Defiance College.

Cedarville's season was largely put together on the deadly shooting of Bruce McDonald, a 5'-10" NAIA all-star who averaged 26 points per game this year.

In a non-conference game with Wilberforce University February 27th, sophomore Bob Warren tied the Cedarville scoring record of 49 points for one game. The 6-4 center from Indianapolis also had 20 rebounds that evening. The fired-up Jacket team won 111-91.

ALUMNI VICTORY

A very spirited Alumni team comprised of Al Knott '68, Jerry Osborne '67, Dennis McDonald '67, Gary Brandes '65, Ted Ochletree '63, Norris Smith '63, Don Cooper '68, and Dozier Carter '66 slipped by the JV's 81-80. High point total went to sharpshooter Norris Smith. Knott and Cooper each had 15 points.

Valuable support was offered by visiting Alumni and wives of players during the closing seconds of a very closely contended match. Some faculty members found themselves re-living some exciting basketball days as two of our all time high game point scorers were sparking the Alumni team.

LIFE-INCOME CONTRACT ISSUED FOR \$25,000

Friends of the college recently gave \$25,000 in securities to the school in exchange for a Life-Income Contract. This type of gift arrangement is a useful tool in Christian stewardship, because it makes possible for donors to receive income for life and at the same time make a significant gift to Cedarville at the time of their death.

A Life-Income Contract is a very simple arrangement. Securities, property, or other assets are given to the college. A Life-Income Contract is written for their current market or appraised value. These assets are invested and all income received goes to the donor(s) for life.

Although Christian stewardship should be the primary motive for giving, there are several advantages to using the Life-Income Contract to make a gift:

1. No capital gains tax is paid for appreciated stocks or property given to the college (normally, a person is taxed on the difference between the original cost price and the sale price).
2. A person can make a charitable deduction for a portion of the gift (this deduction is determined by the age of the donor). If the reduction exceeds 30% of his yearly income, the unused portion may be carried over a five year period.)
3. Usually, a larger income is realized from the Life-Income Contract. A person may be realizing a low yield from an asset, but is prevented from selling by the capital gains tax obstacle. Reinvestment in higher yielding assets are possible for a donor through such a contract with the college who sells the assets without incurring capital gains liability. The donor(s) then receive the higher yield from the new assets.

In summary, the donor receives a Life-Income Contract for the current value of the asset. He is allowed to make a charitable deduction for a portion of the gift, and no capital gains tax is paid. A larger income may be realized through the Life-Income Contract. At the time of the donor's death, the college receives a substantial gift.

May this act of dedicated stewardship encourage others to seek advice on estate planning. The Life-Income Contract is an example of one of many tools that may be used to make a gift to the college.
