### OLD SCIENCE CENTER RENOVATED

Very few alumni are unable to recall the cement floors, oak tables, and 12-foot ceilings of the Cedarville College Science Building. The dual stairways, well illuminated by glass block skylights have been well worn by the feet of every Cedarville student for more than fifty years.

In recent years however, the aging building has come under verbal attack. As a Science Center it was "frightfully deficient". For classroom instruction it would simply be "unsuitable" and "not appropriate".

But all that has changed.

There are now paneled offices, carpeted class and conference rooms, and educational facilities of admirable quality. The old brick walls, sporting attractive orange and yellow glazes, are brilliant illustrations of the rejuvenating process that is launching the "Old Science Building" into its second lifetime as Collins Hall, the new home for the College's Education, Business, and Psychology departments.






This exciting transformation is being made possible by alumni generosity combined with deliberate planning on the part of the family of the late Andrew Gordon and Mary Rife Collins. Through a special memorial fund, conceived as a result of a single anonymous gift in 1970, the Collins sons and daughters are contributing \$50,000 in honor of their parents.

Andrew Collins, a lifetime resident of Cedarville, was extremely active in religious, educational and civic responsibilities. His influence to build Cedarcliff School at its present location was a significant contribution to Cedarville's history. The more popular setting, just north of "Old Main" would have seriously hindered the College's physical growth.

At graduation ceremonies last month, President Jeremiah, in announcing the official designation of Collins Hall, expressed thanks to the family and noted the fact that all eight of the Collins sons and daughters were graduates of Cedarville College.

The entire family was able to be present for the announcement and were recognized not only for their gift to the College, but also for the success which each member has achieved as an alumnus of Cedarville College.



### Educator Award Given

Dr. Robert Gromacki

Dr. Robert Glenn Gromacki, chairman of Cedarville College's Biblical Education department, has been selected by the Alumni Executive Committee as the first recipient of the association's Distinguished Educator Award. The award, which was created by alumni vote in 1972, is a recognition award designed to honor the attainment of outstanding professional stature.

In presenting the award as a part of the College's June 7th commencement exercises, Ron Grosh, Cedarville Alumni President, cited Dr. Gromacki's significant contribution through research and publication in the field of Biblical Studies as well as his exemplary conduct in the classroom and before his colleagues.

It is hoped that the Distinguished Educator Award, which is accompanied by a gift of three hundred dollars, will have the effect of stimulating further productivity and contributing to a spirit of academic leadership within the faculty of Cedarville College.

#### **DOROTHY COLLINS HART**

A 1916 Cedarville Graduate, Dorothy also graduated from the Biblical Seminary of New York and for many years was active in Christian Education in Brooklyn, N.Y. She was the wife of the late Dr. Edward B. Hart, a prominent New York Osteopathic Physician.

#### JOHN W. COLLINS

After graduation in 1917, John married Janet McClellan, a 1918 graduate, and became active in farming. A member of the Cedarville School Board for many years, John also held leadership posts with several Greene County and Miami Valley Milk Producers Associations as well as the National Milk Producers Federation.

#### WILLIAM RIFE COLLINS

William, a 1918 U.S. History graduate, married Edith St. John, an alumnus of Ohio Wesleyan University, and, after superintending the schools of Ross Township and West Liberty, Ohio, joined the MacMillan Publishing Company as a textbook representative. He authored **Ohio, The Buckeye State**, an 8th grade text, while serving as a curriculum consultant and Director of MacMillan's Chicago office.

#### **M. EARLE COLLINS**

M. Earle Collins, class of '23, continued his education at Ohio State University, receiving a Ph.D. in College Administration. He served as Superintendent of Greene County Schools before moving with his wife, Mary Dixon Collins, to Missouri. There, Earle became President, first of Tarkio College, then of Missouri Valley College. He received the LLD from Cedarville in 1948, and, as President Emeritus of Missouri Valley, the LHD from that institution in 1974.

#### PAULINE COLLINS CHOATE

The wife of Robert D. Choate, a former Cedarville student who is the owner and publisher of Elyria, Ohio's Wilmont Press, Pauline, a 1925 alumnus, has been a successful High School Mathematics instructor.

#### **RUTH COLLINS McMILLAN**

Ruth and James McMillan, both 1928 Cedarville graduates, have been active in the ownership and management of the Fairborn, Ohio Daily Herald and the Miami Valley Publishing Company. Mr. McMillan was publisher for 35 years before retirement in 1966.

#### J. ROBERT COLLINS

Dr. Collins, a 1931 grad, and his wife, Lucille Tanner Collins, class of 1930, both continued their education at Western Reserve University. She received the MSLS and served as a high school instructor and Librarian. He earned the M.D. and practiced at St. Lukes Hospital of Cleveland where he became Head of the Department of Obstetrics. Robert is currently a Field Representative for the American Medical Association.

#### **A. ROGER COLLINS**

Roger, a 1919 alumnus and lifetime resident of Cedarville, passed away in January of 1975.



## Sicience Center Campaign Ends

The Alumni of Cedarville College have now contributed over \$100,000 for the campus' new Science Center. This achievement, which marks the end of the association involvement in the project, culminates seven years of consistent support by almost 30% of the College's graduates and former students. The Science Center campaign, which included the special Alumni Annex program, has been the most ambitious venture in the alumni association's history. The result has been the provision of 10% of the facility's total cost, a contribution which will be permanently acknowledged by a plaque at the entrance to the Biological Science Wing.

A significant association milestone was reached during the month of May as the first Cedarville Alumni Chapters came into existence. The chapters are designed to provide a balanced proNever before have the alumni responded to such a degree.


gram of social activities, educational ministeries and service opportunities, and will continue to be developed on a regular basis in areas where alumni interest is shown.

The organizational process began after a brief program, with the distribution of the Cedarville Alumni Chapter Handbook. Responsibilities were then chosen and chairmen elected for the five loosely organized committees which will provide the chapter with programming, alumni relations, public relations, and student recruitment capabilities.



#### What About Home Missions?

In 1950; it was reported that the population of the U.S. was 150 million. Today, that figure has risen to more than 200 million, and the estimate is that by 1980 the population will have risen to as high as 300 million. It has also been estimated that there is a need for 3,000 new churches to be established annually in order to meet the "religious" needs of our people. But statistics show that less than 1,500 new churches are being established by all groups or individuals combined.

One mission board gave these figures in a pamphlet which I recently read. The writer stated that "one out of three Americans is completely pagan, that is, they have no affiliation with a Protestant church, or a Roman Catholic communion, nor a Jewish synagogue, nor one of the heretical isms or cults". What a sobering thought. That means that at least one-third of our people are lost.

There seems to be a great trend toward foreign missions in our circles today. Indeed, there is a real need on the foreign fields around the world— Bangladesh, Africa, Brazil, the Philippines—all of these present us with a great challenge. But what about home missions? I fear that many of us have neglected to consider what its role might be, even here at home. Home missions is viewed by many as a last resort or as that forsaken task which falls upon their shoulders because they were not accepted to go to a "foreign" field.

Since June 15, 1974, I have been working with Pastor Ezell Wiggins, a Fellowship of Baptists for Home Missions Pastor, in Des Moines, Iowa. I have been filling the positions of Assistant Pastor, Youth Director, Christian Ed. Director, and Sunday School teacher. You may ask, "Why so many positions?" The answer is one which any missionary pastor could easily answerlack of personnel.

There is a great need for men and women to take part in the establishment and development of Bible-believing churches. There is also a need for trained workers who are willing to assist in the programs of the churches, once they have been established. Pastor Wiggins has been here in Des Moines for nearly 15 years. In that period of time, other than the students at Faith Baptist Bible College, there has been no assistance of any measurable degree. How many other pastors are there around the country who find themselves in the very same position?

What about home missions? Have you seriously considered that this may be the area of service which the Lord has for you? The needs are tremendous—youth, music, Sunday School, visitation, personal growth. Is there a place for you in home missions? I trust that the Lord will burden your heart to make it a matter of prayer.
