SOUTHWESTERN OHIO COUNCIL FOR HIGHER EDUCATION AND DIRECT BORROWING

Cedarville College is a member, along with 21 other institutions of higher learning and corporations in the Miami Valley, of the Southwestern Ohio Council for Higher Education. This consortium was created to encourage collaborative efforts in education and research. The Centennial Library is a member of the SOCHE Library Council, which sponsors a variety of cooperative activities and resource sharing including arrangements for our daily delivery service, interlibrary loan agreements, and direct borrowing. In the January issue of E-News, the delivery service was explained. In this issue, an explanation of the direct borrowing arrangement follows.

Direct Borrowing Agreement

The agreement provides reciprocal, direct on-site borrowing for all registered faculty, staff, and students in good standing at any of the participating SOCHE member libraries. Approved patrons who borrow from an institution other than their own agree to adhere to the circulation rules of that lending institution.

1. Materials: The agreement involves the general circulating collection only.
2. Borrower Registration: Each lending institution will indicate its required form of identification (usually an institutional ID card and a pictured driver's license) in order to register a patron and loan materials. For all borrowers, the length of registration will be for the current term (semester or quarter) of the lending institution.
3. Loan and Renewal Periods: Each participating institution will provide a minimum of a 14-day loan period for students and faculty from other institutions with no renewals allowed.
4. Borrower Responsibilities: The borrower bears the responsibility for understanding the policies of the lending library, and for the materials borrowed from the time of check-out until the items are returned.
5. Recalls: All material is subject to immediate recall from the patron by the lending library. Borrowers are responsible for returning materials within five days of the notification of

recall.

6. Item Limit: Patrons will be eligible to have on loan at any one time a total of 5 items on a single registered account.

7. Overdue Notices: Each participating institution will send overdue notices directly to the patron according to the normal overdue schedule for that lending institution.

8. Fines: Each participating institution may charge fines up to the amount that would be charged to its own campus borrowers. The lending institution retains all fine revenues for materials it lends.

9. Patron Blocks: To assist in securing the return of materials borrowed from a lending institution, the home institution of the patron agrees to apply any blocks that would normally apply on the home campus. Such efforts may include reciprocal blocking of patron borrowing privileges or other measures as are normal operating procedures for each of the libraries. Lending institutions will report to home institutions the names of patrons who are more than 35 days delinquent in the return of materials. Home institutions agree to block the borrowers from further borrowing at the home institution until all materials are returned and fines paid in full.
